

WHAT IS TH	IS PRODUCT?
Туре :	This product is a fund of MARCH INTERNATIONAL, SICAV, an investment company with variable share capital (SICAV) with multiple funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.
Term :	This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.
Objectives :	The Sub-Fund seeks regular and current income through its emphasis on a conservative equilibrium between bond and equity securities. It also aims to provide long-term capital appreciation through selected investments in equity securities. The Sub-Fund will invest its assets internationally in debt securities, bonds, notes, similar fixed income (including bank deposits) and floating-rate securities convertible bonds, convertible notes and warrant bonds as well as in equity securities. The Sub-Fund may also occasionally invest in ADRs (American Depositary Receipts) and GDRs (Global Depositary Receipts) which may not embed derivatives. The Sub-Fund will not invest more than 10% of its ne assets in Undertaking for collective investment schemes (UCIs). The Sub-Fund may use financial derivative instruments for hedging and/or for othe purposes, including options, forwards, futures and/or swaps on Transferable Securities and/or ther eligible assets as described in the prospectus. The Sub-Fund may also hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps (TRS). The Sub-Fund is actively managed and the investment objectives and strategy do not refer to a benchmark.
	The Sub-Fund launched on 15/12/2010. The Share Class launched on 27/03/2012.
	The currency of the Sub-Fund is EUR, the currency of this product is USD.
	Distribution Policy: Returns and gains are not distributed but are reinvested in the Fund.
Intended retail investor :	The Sub-Fund is suitable for any investor type (institutional and retail investors) including those who are not interested in or informed about capital markets topics, but who see investment funds as a convenient "savings product". The Sub-Fund is also suitable for more experienced investors wishing to obtain defined investment objectives and seeking current income and stability along. Experienced with capital markets products is not required. The investor must be able to accept moderate temporary losses, thus the Sub-Fund is suitable for investors who can afford, in principle, to set aside their capital for a period o at least 3 years.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator

WHAT HAPPENS IF FUNDROCK MANAGEMENT COMPANY S.A. IS UNABLE TO PAY OUT ?

The Management Company, as the PRIIPs manufacturer has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Sub-Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?

Cost over time

The recommended minimum holding period: 3 years.
