WHAT IS THIS PRODUCT?

Туре :	This product is a fund of MARCH INTERNATIONAL, SICAV, an investment company with variable share capital (SICAV) with multiple funds and governed by the Luxembourg Law of December 17, 2010 on Undertakings for Collective Investment.
Term :	This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.
Objectives :	The objective of the Sub-Fund is to provide its investors with capital growth, mainly by investing in units of Undertakings for the Collective Investment in Transferable Securities ("UCITS") and/or Undertakings for collective investment ("UCIs") offering different strategies and the philosophy of which is to achieve an absolute performance. At least two thirds of the assets, excluding cash, will be invested at all times in UCITS and/or UCIs having notably (but no limited to) the following alternative investment styles: "Long Short Equity", "Event-Driven", "Macro", "Relative-Value" and "Protection" (For detailed definition for each of these investment style, please refer to the prospectus). The Sub-Fund's assets must be invested in at least three of these styles without any one of them accounting for more than 50% of the Sub-Fund's total ne assets. The Sub-Fund may invest up to 20% of its net assets in money market instruments and time-deposits or UCIs. However, The exclusive object of which is the collective investment in money market instruments and the placing of deposits with credit institutions.
	The Sub-Fund shall not invest more than 30% of its net assets in units of other UCIs (other than UCITS). The Sub-Fund may also hold ancillary liquid asset (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The Sub-Fund may invest in financial derivative instruments, including but not limited to FX forwards, for hedging and efficient portfolio management purposes. The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps (TRS). The Sub-Fund is actively managed and the investment objectives and strategy do not refer to a benchmark.

The Management Company, as the PRIIPs manufacturer has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Sub-Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?
