#### WHAT IS THIS PRODUCT?

Type: This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term: This product has no maturity date. However, the Board of Directors may decided to close the product under certain circumstances.

Objectives:

The Sub-Fund seeks regular and current income through making investments in bonds, equity securities and bank deposits on a global and opportunistic basis. It also aims to provide long-term capital appreciation through selected investments in equity securities. The Sub-Fund will invest, directly or indirectly through Undertaking for Collective Investment in Transferable Securities ("UCITs") or other eligible Undertaking for collective investment ("UCIs"), its assets in debt securities, bonds, notes, fixed income securities, bank deposits, floating rate securities, convertible bonds (provided that investment in Contingent Convertible Bonds ("CoCos") will not exceed 7% of the Sub-Fund's Net Asset Value), convertible notes, Real estate investment trusts (REITs) and warrant bonds as well as equity securities. The choice of investments will neither be limited by geographic area (including emerging countries), an economic sector, nor in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country and/or in a single economic sector and/or in a single currency. The total exposure to the asset classes listed below, whether direct or indirect, will not exceed the limits specified below (in percentage of the total net assets of the Sub-Fund):

- Cash and cash equivalent investments (including Money Market Instruments): 0%-40%
- Government bonds issued by EU and non EU countries with a rating of not less than B-: 0%-80%
- Corporate bonds: 0%-80%
- Investment Grade bonds: 0%-80%
- High Yield bonds: 0%-80%
- Equity: 20%-80%
- Alternative Funds: 0%-25%
- REITs: 0%-20%

In order to achieve the above objective and to ensure the liquidity of the Sub-Fund, the Sub-Fund will invest in Money Market Instruments (i.e., cash and cash equivalents) at all times. The Sub-Fund may use financial derivative instruments for hedging and/or for other purposes, including options, forwards, futures and/or swaps on Transferable Securities and/or other eligible assets as described in the prospectus. The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps ("TRS"). The Sub-Fund is actively managed and the investment objectives and strategy does not refer to a benchmark.

The Sub-Fund launched on 20/12/2016. The Share Class launched on 20/12/2016.

The currency of the Sub-Fund is EUR, the currency of this product is EUR.

Distribution Policy: Returns and gains are not distributed but are reinvested in the Fund.


Intended retail investor:

The Sub-Fund is suitable for Retail Investors and Institutional Investors who understand and are able to bear the risks of an investment in the Sub-Fund, including the risk of losing all or substantially all of their investment. The Sub-Fund is suitable for investors who can afford, in principle, to set aside their capital for a period of at least 2-3 years.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator





The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

#### WHAT HAPPENS IF FUNDROCK MANAGEMENT COMPANY S.A. IS UNABLE TO PAY OUT?

The Management Company is responsible for administration and management of the Sub-Fund, and does not typically hold assets of the Sub-Fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the PRIIPs manufacturer has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Sub-Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

#### WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return).

#### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended minimum holding period: 5 years.

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
