WHAT IS THIS PRODUCT?

Type: This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term: This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

The aim of the Sub-Fund is to provide long-term capital appreciation through selected investments in listed equity securities of companies involved in the Objectives: design, manufacture or sale of products and services in connection with the seas and water management sectors. The strategy has a supportive environment that is backed by global mega-trends such as population growth, environmental constraints, supportive regulation, and global wealth creation.

The Sub-Fund will be unrestricted in its choice of companies either by size, industry or geography.

The Sub-Fund aims to invest in companies producing and distributing drinking water to consumers. The Sub-Fund also looks for companies active in collection and treatment of wastewater, as well as those developing water technologies for companies and consumers. The Sub-Fund will also invest in companies developing efficient irrigation systems or improving waste management, thereby protecting groundwater quality. In addition to the above strategy, the Sub-Fund will invest in sectors related with oceans and seas activities such as such as ocean's pollution prevention, carbon transition in maritime transportation, reducing plastic pollution, maritime technologies, renewable energy, circular material flows, etc. The Sub-Fund may invest in equities, and occasionally in American Depositary Receipts ("ADRs") and Global Depositary Receipts ("GDRs") which may not embed derivatives. The Sub-Fund may also hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The Sub-Fund will not invest more than 10% of its net assets in undertakings for collective investment. The Sub-Fund may use financial derivative instruments for hedging and/or for other purposes, including options, forwards, futures and/or swaps on Transferable Securities and/or other eligible assets as described in the prospectus. The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps (TRS)

The Sub-Fund qualifies as an Article 8 product under SFDR. The Sub-Fund is managed to promote, among other characteristics, a combination of environmental and social characteristics, and will additionally invest a minimum proportion of 20% of its net assets in a combination of sustainable investments as defined by SFDR and investments in economic activities that qualify as environmentally sustainable as defined by the Taxonomy Regulation (the commitment to the latter is a 0% minimum proportion within the previously mentioned 20%). The Investment Manager integrates sustainability risks and opportunities into its research, analysis and investment decision-making processes. This Sub-Fund aims to provide capital growth. least 5 years.
