WHAT IS THIS PRODUCT?

Type: This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term: This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives:

The aim of the Sub-Fund is to seek long-term capital appreciation by investing in listed equity securities of companies of capitalisation equal or greater than 2 billion EUR or equivalent whose success is mainly based on intangible assets (network effect, brand equity, human capital and intellectual property, among others) that can be maintained over the long-term, and which represent a source of revenue creation for the target company, mainly in North property and the company of the source of revenue creation for the target company, mainly in North property and the company of the source of the company of the compan

The Sub-Fund may also hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The Sub-Fund may also invest in bank deposits, money market instruments, or money market funds in accordance with the applicable investment limits in order to meet its investment objectives and for treasury reasons. The Sub-Fund, in order to mitigate risks relative to exceptional market conditions, may invest up to 100% of its net assets in such assets on a temporary basis and if justified by exceptionally unfavourable market conditions in the best interests of the Shareholders. The Sub-Fund will use the commitment approach to monitor its global exposure. The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps ("TRS").

The Sub-Fund is actively managed and the investment objectives and strategy do not refer to a benchmark.

The Sub-Fund launched on 15/12/2010. This Share Class is not launched yet.

The currency of the Sub-Fund is EUR, the currency of this product is USD.

Distribution Policy: Returns and gains are not distributed but are reinvested in the Fund.

Intended retail investor:

The Sub-Fund is suitable for any investor (institutional and retail) who understands and is able to bear the risks of an investment in the Sub-Fund, including the risk of losing all or substantially all of his/her/its investment. The Sub-Fund is suitable for investors who can afford, in principle, to set aside their capital for a period of at least 5 years.

The recommended minimum holding period: 5 years.
